issued by Minister of Trade and Industry on amending the rules regulating registration of eligible factories to export their products to the Arab Republic of Egypt

Minister of Trade and Industry,

Having taken cognizance of Law No. 118 of 1975 with respect to Export and Import; and

Ministerial Decree No. 770 of 2005 regarding Rules and Regulations implementing Provisions of Law No. 118 of 1975 mentioned above;

Ministerial Decree No. 992 of 2015 on the Rules regulating registration of the eligible factories for exporting their products to the ARE; and

Upon what is submitted by the two Sectors of Trade Agreements and Foreign Trade.

Decides

Article No.: (1)

The General Organization for Export & Import Control shall establish a record for factories and companies, owning trademarks, eligible to export products set forth in the attached statement to the Arab Republic of Egypt.

Such products, imported for the purpose of trade, may not be released unless they are produced by the registered factories or imported from companies owning trademarks or from their distribution centers registered in this registry.

Registration in this registry or writing off the same shall be under a decree issued by the Minister of Foreign Trade. The Minister shall be entitled to make exemption from any or all registration requirements as the case may be. Arab Republic of Egypt Ministry of Trade and Industry The Minister

Article No.:(2)

Registration in the registry hereinbefore referred to shall be stipulated by the following:

First: As for factories

The registration application shall be submitted by the legal representative of the factory or his authorized person or his agent supported with the following authentic documents:

- A certificate of legal status of the factory and the license issued therefor.
- A statement of the items produced by the factory and trademarks thereof.
- The product's trademark and the trademarks produced under a license from the owning entity.
- A certificate proving that the factory applies a quality control system issued from an entity recognized by International Laboratory Accreditation Cooperation (ILAC), International Accreditation Forum (IAF), or a governmental or foreign entity approved by the Minister of Foreign Trade.

Second: As for companies owning trademarks

The registration application shall be submitted by the legal representative of the factory or his authorized person or his agent supported with the following authentic documents:

- A certificate proves registration of the trademark and the products produced under this trademark.
- A certificate from the company owning the trademark at the distribution centers permitted to supply the items bearing such trademark.
- A certificate proving that the company owning the trademark applies a quality control system issued from an entity recognized by International Laboratory Accreditation Cooperation (ILAC), International Accreditation Forum (IAF), or a governmental or foreign entity approved by the Minister of Foreign Trade.

Third:

In case of suspecting the authenticity of the submitted documents, registration shall be conducted only after the documents are being verified. Upon request of the registration applicant, the company or the factory may be inspected for ensuring the authenticity of the documents after the approval of Minister of Trade and Industry.

Article No.:(3)

All other provisions contradicting such decree shall be repealed.

Article No.:(4)

This decree shall be promulgated in the Official Gazette and shall be effective two months after the date of promulgation hereof.
