# The most important achievements of the General Organization for Export and Import Control during the year 2022

The number of letters presented to the General Organization for Export and Import Control during the year 2022 reached (103,392) letters.

### Industrial imports:

The number of industrial import letters reached (81,377) messages. The number of (78,055) letters was accepted, and (3322) letters were rejected.

#### Non-industrial imports:

Non-industrial import letters reached (22015) letters, (21477) letters were accepted and (538) letters were rejected.

The messages presented to GOEIC laboratories amounted to (249,796) messages during the year 2022.

#### The Certificate of origin:

The General Organization for Export and Import Control issued (362,893) certificates of origin during the year 2022, in accordance with the protocols

of the rules of origin applied in the preferential agreements concluded between Egypt and other countries for the application of customs exemptions and benefits granted to Egyptian exports. These certificates were between (the emblem of the League of Arab States- Bilateral agreement - COMESA - MERCOSUR - EUR1 - EUR MED – FORM-A - G.S.T.P -AFCFTA).

## The most important events for 2022:

3. The field of accreditation for biodegradable plastics and detergents has been extended in the chemical and food testing laboratories at GOEIC branch at Cairo Airport by the National Accreditation Council (EGAC).

4. Based on the decision of the Minister of Trade and Industry, the General Organization for Export and Import Control was assigned to issue free sale certificates exported abroad.

9. Starting the trial operation of the industrial laboratories in GOEIC branch in Ain Sukhna.

10. Completion of GOEIC laboratories development Lab and the opening of several laboratories in GOEIC various branches, such as:

• Opening of the new laboratories building at GOEIC branch in Dekheila Port, Alexandria.

• Opening of chemical and food testing laboratories at GOEIC branch in Nuweiba.

• Opening of GOEIC office in the Chamber of Commerce in Benha.

• Opening of the energy efficiency testing laboratory for electric motors at GOEIC branch in Cairo Port.

• Opening of the developed building for GOEIC branch at Cairo Airport.

12. 33. Pursuant to the directives of the President of the Republic, attention must be paid to workers who are central to development.
