

Top achievements of the General Organization for Export and Import Control for 2023

Number of shipments Submitted to the General Organization for Export and Import Control (105,321)

Industrial imports:

The Numbers of shipments (89670), the accepted was (82429) and the rejected was (7241)

Non-industrial imports:

The Numbers of Shipments (15,651), the accepted was (15,081) and the rejected was (570).

GOEIC's laboratories examined the number of (464044) shipments during 2023

Food and Chemical laboratories:

Number (276,841) of samples, of which (29,940) are contracted samples.

Industrial laboratories:

Number (187203) of samples.

Origin:

The General Organization for Export and Import Control issued a number of 423,206 certificates of origin during 2023, in accordance with the protocols to the rules of origin applicable to the preferential agreements concluded between Egypt and other States for the application of exemptions and customs benefits granted to Egyptian exports.

Training:

A total of 2,972 trainees were trained during 2023. Some of the most important training programs (export practice, import practice, laboratory inspection of exported and imported goods in GOEIC's laboratories, ISO programs, and other different programs).

Commercial registrations:

Total of (29,887) records were extracted during the year (2023) including new entries, renewals, and additions and the data showed the volume of work as follows:

3. Register of commercial agents and foreign offices: 1632

The General Organization for Export and Import Control has made many achievements in the field of construction and development:

- 1- The opening by His Excellency the Prime Minister of the new central laboratories of the branch of the General Organization for Export and Import Control in the port of Ayn Sokhna in the presence of His Excellency the Minister of Trade and Industry.
- 2- The establishment of offices at the headquarters of chambers of commerce in several governorates such as Gharbia and Cairo to facilitate customers with the Organization. All services are provided to exporters and importers in the framework of digital transformation and are delivered as soon as possible in order to save time and effort instead of heading to major ports.
- 3- Opening the development work of GOEIC's hostel in Alexandria as part of a plan to develop GOEIC's hostel and renovate all its infrastructure works in a manner befitting the esteemed colleagues working in the organization.

Quality and product conformity

Each of the following has been accredited:

1. Laboratory (Acoustic Tests - Safety Tests), Cairo Airport Branch
2. Examine tests of all types of cement in chemical Laboratories at GOEIC 's branch in Damietta port.
3. (3) of tests in three laboratories (Water Pump Laboratories - Acid Battery Laboratories - Electric Motor Laboratories) of GOEIC's Port Said port branch.
4. Petroleum Products Testing Laboratory at GOEIC's Branch in Suez Port.

The accreditation has been renewed and its scope extended to include:

1. Quality certificate in the management system in accordance with international standard ISO:9001
2. Inspection laboratories (batteries - lighting units - electrical cutters - household appliances - electrical switches - pumps) at GOEIC's branch at Cairo Airport
3. Number (9 tests at the shoe and leather factory - lighting units test - 7 tests at the low voltage cable Laboratories) of GOEIC's branch in the port of Suez.
4. Cairo Airport Branch Laboratory (Optical Tests).
5. Number of 3 tests (energy efficiency for household vacuum cleaners - energy efficiency for household electric fans - energy efficiency for electric ovens.
6. 3 tests in three laboratories (leather and footwear laboratories (12 tests) - dry batteries and generating cells - koalin) at GOEIC's Port Said branch.
7. The valves and pumps laboratories at GOEIC's branch in Alexandria port

The accreditation scope of the unit for issuing certificates of conformity for internationally approved products has been extended in accordance with the requirements of ISO17065:2012 and registered with the Saudi Standards, Metrology and Quality Organization (SASO) in 4 new areas. The unit is now permitted to use the accreditation logo in accordance with the Council's rules of operation, which include: (Electric battery products - Detergent products - Paper and cardboard products - Food contact kitchenware products).

Thus, GOEIC's Product Conformity Certification Unit is awarded conformity certificates in 8 areas:

1. Textile products.
2. Shoes and accessories.
3. Leather products.
4. Biodegradable plastic products.
5. Paper and carton.
6. detergents.
7. Products of tools and appliances used in the kitchen.
8. Electric batteries.

GOEIC's Conformity Certification Unit issued a number of 60 product conformity certificates to the Saudi Saber system, including the most important products (detergents, textiles and shoes), whose laboratory tests were passed by the Chemical Organization 's laboratories. The Unit also conducted 70 field visits to qualify factories for export.

More than 85 Egyptian companies originating from African and Arab countries (Tunisia, Morocco, Kuwait, Algeria, Saudi Arabia, Jordan, Nigeria, Brazil, Russia, UAE) have been issued with a free sale certificate, including soap and personal care items.

Development of services to the business community:

1. The second phase began the implementation of the new technical cooperation project between GOEIC, the National Calibration Institute and the German National Institute of Metrology, which aims to enhance the competitiveness of the Egyptian economy by enhancing the capabilities and adding new services to the list of services provided by the National Calibration Institute to new customers in the agri-food sector in Egypt.
2. The Memorandum of Understanding was signed to commence the implementation of the Korean KSP Program project for the establishment and development of Goeic's integrated risk management system in conformity assessment and inspection procedures for industrial goods in accordance with the latest systems and global standards Protocols:

GOEIC is keen to conclude several protocols of joint cooperation with many agencies with a view to cooperating jointly in the transfer of experiences and the exchange of information, including:

1. A joint cooperation protocol with the Egyptian Export Guarantee Company. The protocol aims to exchange information and data on Egypt's foreign trade, disaggregated by countries, conventions and various production sectors, and to provide all information and data available to the Organization on the classification of imported and exported goods according to their priorities and importance to the Arab Republic of Egypt.
2. A joint cooperation protocol with the Export Council for Printing, Packaging, Paper, Books and Technical Works with the aim of cooperating between the parties in the field of chemical analyses at GOEIC's laboratories and exchanging information and data. This step is a contribution to supporting the printing and packaging sector to facilitate the termination of procedures for the sector's companies.
3. A joint cooperation protocol with TÜV Austria, which aims at exchanging experiences and conducting food, chemical and industrial analyses at GOEIC's laboratories approved locally and internationally. This protocol comes after several years of fruitful cooperation between the company and the Organization in the field of examination of food and chemical products at the level of Egyptian exports and imports.
4. Joint Cooperation Protocol with the Egyptian Exporters' Association (Expolink) with the aim of upgrading and building the capacity of new exporters and entrepreneurs in the field of training on export practice program, certified Exporter program and other programs offered by GOEIC's work, its activities and services, as well as any developments in the process of regulating exports and imports.
5. A joint cooperation protocol with the Egyptian Pharmaceutical Organization aimed at complementing efforts and cooperation between the two sides in the transfer of expertise, exchange of information and the holding

of induction seminars, stressing the critical strategic importance of the Egyptian market for medical preparations and supplies, and the paramount importance of exports of various medical preparations in support of the Egyptian economy.

6. Signing a joint cooperation protocol with the National Organization for Egyptian Post aimed at facilitating the movement of trade, developing and encouraging Egyptian exports and overcoming any obstacles to their prosperity, development and expansion in all fields by taking advantage of the enormous potential and diverse services provided by the National Postal Organization.
7. A joint cooperation protocol with Heliopolis University with the aim of sharing experiences in the field of carbon footprint assessment, organizing and holding training activities (courses - workshops) to raise awareness about global warming, climate change and carbon footprints.

Cooperation with private sector companies:

1. Within the framework of the need to cooperate with and support private sector companies in technical aspects in order to encourage Egyptian export movements, GOEIC visited a number of companies and factories such as:
 - Visit Sidi Creer Petrochemical Company and explore ways of cooperating in the field of biodegradation tests. Carbon emissions from different products are one of the third range factors in calculating carbon footprint as well as offering the services of GOEIC's certified inks, paints, plastics and polymers testing laboratories. Sidi Creer Petrochemicals Company is the first petroleum company to register with the approved Exporter system.
 - Visit the Siraj (Flair) factory specializing in the design and manufacture of lighting solutions that comply with various projects in the new economic zone of the Suez Canal to visit the latest laboratories of GOEIC in the port of Ain Sokhna.
 - Visit the Egyptian Chamber of Commerce in Alexandria to discuss the mechanisms of cooperation between the Chamber and GOEIC and answer all questions of Customs Extractors.
 - The presentation of numerous television meetings in programs "Al-Shahbandar - Today Program - DMC Evening Program and a live program from Egypt on CBC EGYPT" to review the role of GOEIC in stimulating Egyptian exports to reach 100 billion exports and explain the mechanisms for the application of the risk management system.
 - Egyptian Television filmed several television meetings with the leading leaders of GOEIC in the framework of a review of the role of GOEIC and its services to the business community and efforts to support Egyptian exports abroad.

Human development:

In pursuance of the presidential directives on the importance of attention to human wealth because it is a key pillar for achieving inclusive and sustainable development: GOEIC has established a center of excellence qualified to prepare human cadres that will be the nucleus of future construction and development, which in turn has undertaken several training courses:

- Reception of Egyptian university students to train in various examinations and provide training opportunities for about 1,000 students from Egypt in all practical disciplines. The aim is to upgrade their capabilities and develop their technical skills in accordance with the needs of the labor market with the required efficiency in coordination with Egyptian universities, including "Al-Azhar Universities - Cairo - Ain Shams - Helwan - Damietta - South Valley - Canadian Institute". The training took place in the branches of GOEIC in several governorates.
- Training courses for employees of GOEIC in cooperation with private sector companies such as (SGS-Brooker) in order to improve the efficiency of their youth cadres in central laboratories of chemical and food goods and familiarize them with the new in various fields of inspections.
- Training course for all leaders of GOEIC in cooperation with TÜV Austria to identify the requirements of energy management systems in accordance with ISO 50001 of 2018 in the framework of GOEIC's role in supporting the green economy and rationalizing energy.
- Training courses for delegations from of the Sudan and Somalia to learn about GOEIC's capabilities and exchange experiences in the field of inspection and quality control. The training included the inspection of electric heaters in coordination with the Arab Foundation for Consultation, Training and Performance Development.
- Training course for students of the Food Safety Diploma of the Maritime Academy of Science and Technology for training in various inspections work where they received their training at the recently developed microbiological laboratory and upgrading its infrastructure and equipping it with the latest rapid screening devices.
- Training course for business and exporters interested in exporting on "Advanced skills in managing financial and monetary export risks and developing an export strategic plan".

Women's and Equal Opportunities Unit:
