





- 1. General format and display of the GOEIC EVVU environmental validated/verified symbol or reference to GOEIC EVVU environmental validation/verification:
- 1.1 GOEIC EVVU logo is to be used by GOEIC EVVU only. Environmental validated/verified clients may not use GOEIC EVVU logo in such reference and as explained in the following:



- 1.2 Environmental validated/verified clients may use GOEIC EVVU environmental validated/verified symbol and/or may make a reference to their GOEIC EVVU environmental validation/verification, but may not use GOEIC EVVU logo in such reference.
- 1.3 GOEIC EVVU environmental validated/verified symbol shall be displayed only in the appropriate CMYK format, colour, reserving the dimensional ratios (length, width, diagonal) and wording as provided by GOEIC EVVU in an electronic form and as explained in the following:



- 1.4 Where a client wishes to refer to its GOEIC EVVU environmental validation/verification instead of using the symbol it shall without variation use the relevant phrase "A GOEIC EVVU environmental validated/verified client No.000000"
- 1.5 All quotations that contain the GOEIC EVVU environmental validated/verified symbol or refer to GOEIC EVVU environmental validation/verification shall clearly indicate those activities that are not GOEIC EVVU environmental validated/verified.
- 1.6 A client environmental validated/verified by GOEIC EVVU is entitled to display GOEIC EVVU environmental validated/verified symbol or make reference to GOEIC EVVU environmental validation/verification on sheets of its stationery (e.g. letterhead paper, quotations, brochures) or other items relevant to the environmental validated/verified activity, subject to CLIENT identifying the specific areas for which it is environmental validated/verified.
- 1.7 A client environmental validated/verified by GOEIC EVVU shall, in addition to all other requirements detailed in this document, display, on any documentation it chooses, GOEIC EVVU environmental validation/verification number with the GOEIC EVVU environmental validated/verified symbol.
- 1.8 A client environmental validated/verified by GOEIC EVVU may not imply in their use of GOEIC EVVU environmental validated/verified symbol or in any reference to GOEIC EVVU environmental validation/verification that GOEIC EVVU approves their product, service, management system, personal or process
- 1.9 A client environmental validated/verified by GOEIC EVVU that holds environmental validation/verification in more than one field shall ensure that it does not imply environmental validation/verification for any field which it does not have environmental validation/verification for.
- 1.10 Failure to comply with these requirements may lead to denial, suspension or withdrawal of environmental validation/verification and/or legal action. (See item 2.)

- 2. Use of GOEIC EVVU environmental validated/verified symbol or reference to GOEIC EVVU environmental validation/verification in publicity material:
- 2.1 Environmental validated /verified client are entitled to incorporate GOEIC EVVU environmental validated/verified symbol in publicity material that refers to environmental validated/verified services provided that the conditions in this document are met. Environmental validated/verified client are also entitled to make general reference to GOEIC EVVU environmental validation/verification provided that they ensure that GOEIC EVVU environmental validation/verification is not implied for non-validated/verified activities. Note: Where reference is made to having GOEIC EVVU environmental validation/verification the client must ensure that it does not imply environmental validation/verification for areas not environmental validated/verified.
- 2.2 GOEIC EVVU environmental validated/verified symbol shall not be used in literature relating to a product unless it is directly located adjacent to the reference to the validated/verified function.
- 2.3 Approval for the use of GOEIC EVVU environmental validated/verified symbol or any reference to GOEIC EVVU environmental validation/verification in publicity material relating to a product must be obtained from GOEIC EVVU.
- 3. Other restrictions on the use of GOEIC EVVU environmental validated/verified symbol or reference to GOEIC EVVU environmental validation/verification:
- 3.1 GOEIC EVVU environmental validated/verified symbol or any reference to GOEIC EVVU environmental validation/verification shall not be displayed on a test item, or product (or attachment thereto) or used to imply product certification.
- 3.2 GOEIC EVVU environmental validated/verified symbol or any reference to GOEIC EVVU environmental validation/verification shall not be used in such a way as to imply that GOEIC EVVU accepts responsibility for the accuracy of a calibration or test result, or any opinions or interpretations derived thereon, or approves a calibrated instrument, test item or product.

- 3.3 Subject to conditions stated in this document, the use of GOEIC EVVU environmental validated/verified symbol or reference to GOEIC EVVU environmental validation/verification on items other than reports or certificates is not discouraged, but shall be subject to agreement by GOEIC EVVU.
- 3.4 A CLIENT environmental validated/verified by GOEIC EVVU shall upon suspension, reduction or withdrawal of GOEIC EVVU environmental validation/verification immediately stop to use symbol and any other materials displaying GOEIC EVVU environmental validated/verified symbol or containing references to GOEIC EVVU environmental validation/verification and shall informs its affected clients of the suspension, reduction or withdrawal of its environmental validation/verification and the associated consequences without undue delay.
- 3.5 GOEIC EVVU shall take appropriate action to deal with incorrect use of any of its environmental validation/verification symbols or reference to environmental validation/verification. This action may include:
- Request for corrective actions;
- Withdrawal of certificates/reports;
- Publication of transgression, and if necessary
- Suspension/withdrawal of environmental validation/verification and/or legal action.
- 3.6 GOEIC EVVU permit environmental validated/verified clients to use GOEIC EVVU environmental validation/verification symbol in communications media where media could be TV, Radio, Newspapers, Trade journals, Flyers, advertisements etc with only GOEIC EVVU written permission
- 4. Responsibilities: Clients.
